**Statement of Meeting Procedures.** Welcome to the Northern Sonoma County Air Pollution Control District's ("NSCAPCD" or "District") Board of Directors meeting. If you wish to speak on an issue not appearing on the agenda, you may do so during the public comment period. However, please note that the Board is not permitted to take action on topics addressed under public comment. All items that are listed on the agenda will be open for public comments before final action is taken. The Board requests that you state your name and association for the record before you speak. Be aware that there is a 5-minute time limit per speaker, and the Chairperson has the discretion to limit the total discussion time on any item. Please place all cell phones in silent mode. Thank you for your participation and cooperation.

[5] **Approval of Minutes:** April 27, 2023, Regular meeting.

**Public Comment:** Any person desiring to address the Board on any item not on the agenda, which is within the jurisdiction of the Board, may do so at this time. No action will be taken on any issue not currently on the agenda.

**REGULAR CALENDAR**

[10] **1. Action Item: Hearing and Adoption of Proposed District Budget for FY 23/24.** Conduct a Public Hearing in accordance with the Health and Safety Code § 40131(3)(A) that states: "The district shall notice and hold a public hearing for the exclusive purpose of reviewing its budget and of providing the public with the opportunity to comment upon the proposed district budget." This meeting concludes a 30-day public comment period and the District proposes adoption of Resolution #23-06 to approve the final FY 23/24 District budget.

[10] **2. Action Item: Geysers Air Monitoring Program (GAMP).** Under a MOU, the GAMP is a consortium of government, community, and industry partners that operate three monitoring sites in Lake County. The District is being asked by GAMP to manage a monitoring services contract for up to a 6-month period. Monitoring services are paid for by GAMP industry

members and no District funds. In addition, staff proposes formal notification to the GAMP steering committee regarding the District's future role in the MOU.

- [20] **3. Action Item (Closed Session): District Counsel (CLERE) Employment Contract.** Pursuant to Government Code § 54957(b)(1&4), the Northern Sonoma County Air Pollution Control District Board of Directors will hold a closed session to discuss renewal of the District Counsel services contract. A report on any action taken will be presented prior to the meeting adjournment. The District proposes approval of District legal services contract for CLERE Inc. for FY 2023-2025.
- [20] **4. Action Item (Closed Session): Air Pollution Control Officer (APCO) Employment Contract.** Pursuant to Government Code § 54957(b)(1&4), the Northern Sonoma County Air Pollution Control District Board of Directors will hold a closed session to discuss renewal of the APCO employment contract. A report on any action taken will be presented prior to the meeting adjournment. The contract has been reviewed by the APCO and is being presented for consideration and approval by the Board. Contract term is for FY 2023-2025.
